The 8th Academic Council meeting was held on Tuesday, 22nd April 2025 at 10.00 a.m. in the Open Access Library.

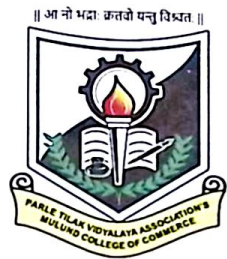

Backlog Management for Community Engagement Project:

- I. Students who will be declared fail in the Community Engagement Project in their regular/first attempt, shall be provided with an opportunity to clear their backlog by resubmitting the pending components of the project.
- II. Students who fail due to non-completion of the mandatory 60 hours of NGO work shall be required to complete the entire 60 hours by working with NGO. These hours may be completed either with the pre-allotted NGO or with a self-identified NGO, subject to prior approval from the designated batch mentor. Alternatively, students may fulfill the 60-hour requirement through community service activities conducted under the guidance of the National Service Scheme (NSS) of the college.
- III. Students who fail due to partial completion (i.e., completion of less than 60 hours) shall be required to complete the remaining hours of NGO work with the pre-allotted or approved NGO, as applicable.
- IV. In cases where the pending component pertains solely to the submission of reports and/or the final presentation, the community work of 60 hours already completed with the pre-allotted or approved NGO may be considered valid for resubmission purposes.
- V. It shall be the responsibility of the student to contact their assigned mentor to discuss the backlog management plan, obtain feedback, and ensure that all pending requirements are completed and submitted within the deadlines prescribed by the College.

Assessment Criteria for On-the-Job Training:

Backlog Management for On-the-Job Training:

- I. Students who are declared failed in the On-the-Job Training (OJT) during their regular/first attempt shall be provided with an opportunity to clear the backlog by resubmitting the pending components of the OJT, in accordance with institutional guidelines.
- II. If the pending component involves incomplete mandatory hours of On-the-Job Training and the student wishes to complete:
 - i) The training with the same employer, the student shall be permitted to complete only the remaining hours necessary to fulfill the 120-hour requirement.
 - ii) The training with a different employer, the student shall be required to undergo the full 120 hours of training afresh.
- III. In cases where the pending component pertains solely to the presentation OR submission of reports (as per the prescribed format) and presentation OR submission of reports (as per the prescribed format), presentation and viva, the OJT of 120 hours already completed by the student may be considered valid for resubmission purposes.
- IV. It shall be the responsibility of the student to contact their assigned mentor to discuss the backlog management plan, obtain necessary feedback, and ensure that all pending requirements are completed and submitted within the prescribed deadlines.

Discussion and Suggestion

Prin. Dr. Kailash Anekar inquired about the number of attempts that would be allowed for the resubmission of the OJT (120 hours), community work (60 hours), and fieldwork, all of which were already completed in the initial attempt. Mr. Amit Yadav stated that since the University allows students to clear their backlog within a period of 7 years, sufficient attempts should be given to them. Dr. Sonali Pednekar suggested that three attempts, excluding the original attempt, should be allowed for the resubmission of already completed work. This was agreed by all and would be incorporated in the Policy. Prin. Dr. Kailash Anekar also wanted to know who would bear the travelling and other expenses for NGO visits under CEP to which Prin. Dr. Sonali Pednekar replied that the fee structure will be covering a component related to OJT, CEP and CC. Dr. Sulbha Dey also informed the council that the students are allotted NGO according to their location and preference for nature of work. The students are also allowed a change in the allotted NGO with prior approval and reason.
