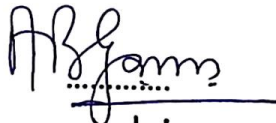
"RESOLVED THAT the Budget for the academic year 2023-24 and the fee structure as proposed from the academic year 2023-24 are unanimously approved."

There being no further business to be discussed, the meeting was concluded with a vote of thanks to the chair.

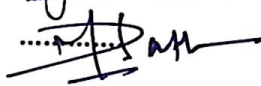

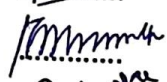

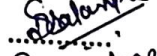
