b. Syllabi for courses offered under all programs:

Principal presented the detailed syllabi for Third Year Under Graduate programs - B.Com., BFSI, B.Com. (MS), BAMMC, B.Com. (BA) and Post Graduate programs under NEP from the Academic year 2025-26, that were approved in the Academic Council, for approval of Governing Body.

The Governing Body unanimously approved the syllabi for the same.

c. Academic Calendar for AY 2025-26.

The Academic calendar for the academic year 2025-26 was presented before the GB including schedule for CC/FP/CEP/OJT.

The academic calendar for the year 2025-26 was discussed and approved.

d. Draft Policy for OJT.

Principal presented the OJT policy consisting the data management, supervision and SOP of the same.

She also explained assessment and non-completion guidelines of Co-curricular Courses (CC), Field Project (FP), Community Engagement Project (CEP), OJT.

The Governing Body unanimously approved the same.

e. Bridge Courses.

Principal informed the GB about two bridge courses for First Year students across all programmes to help students from different streams cope with the syllabi of Accountancy and Mathematics-

- i) Basics of Accounting
- ii) Basics of Mathematics

Both the courses were considered and approved by the Governing Body.

4) To consider the appointment of Professor of Practice for academic year 2025-26.

Principal shared a detailed information related to appointment of Professor of Practice. She explained further the responsibilities of Professor of Practice regarding designing a course, selection of students by aptitude test, batch of 30 students preferably from TY Banking & Insurance and M.Com BF.

Principal mentioned that alumni Mr. Sunil Sathe has shown his interest in working as PoP & it has been unanimously appreciated.

1 for BAF (CA preferred)

The GB suggested that these posts can be advertised.

6) To report on Minor Research Projects funded by Management.

Principal explained the details of minor research projects awarded under Research Policy of College.

MRP approved for 1 Faculty - Dr. Vaishali Patil and 10 Student projects. List of the students with the MRP title is enclosed.

Submission done by 1 Faculty and 08 student projects. Student projects will be scrutinized by internal members from Research Promotion & Assessment Committee. Faculty MRP Report will be scrutinized by external experts.

One research paper based on MRP presented in research conference and selected for publication in SCOPUS Indexed Journal.

GB appreciated the students for the acceptance of their research paper in a SCOPUS journal for publication.
