3) To approve minutes of meeting of Academic Council held on 14/11/2025.

Principal presented the highlights of the minutes of the Academic Council as follows:

a. To approve ATKT rules:

Controller of Exams presented the revised progression rules (ATKT rules) prepared in the interest of the students and in accordance with University of Mumbai Circular No. 2025-26/38 dated 28th May 2025, which have been approved and ratified for implementation by the College in the Academic Council for approval of Governing Body. The revised rules shall be applicable to all students admitted to undergraduate programmes from the academic year 2024-25.

The Governing Body unanimously approved and ratified the ATKT rules.

b. To approve Examination Reforms implemented to strengthen the evaluation and assessment processes:

Controller of Exams presented the examination reforms implemented to strengthen the evaluation and assessment process in the first term of the academic year 2025-26 which have been approved and adopted by the Academic Council for approval of Governing Body.

The Governing Body unanimously approved the examination reforms.

c. To approve the syllabi of various UG programmes and revision in the syllabi or course title :
Controller of Exams presented the syllabus for a new course to be introduced by the Dept. of EVS and proposed the changes in syllabus for the department of BBI, BAF and FM for Semester I as per Appendix A, which are approved in the Academic Council.

The Governing Body unanimously approved the syllabi and the changes in the courses.

d. To approve and recommend the syllabi proposed by the BOS of various PG Programs.
CA Dr.Anuradha Ganesh presented the syllabus for M.Com. (Banking and Finance) for Sem-II for the course of Legal Framework of Banking under NEP and Data Analysis for Business Management , which has been approved by academic council from the academic year 2025-26.

The Governing Body unanimously approved the syllabi proposed by the BOS of various PG programs.

Dr.Mala Lalwani suggested to constitute an Ethics Board. This idea was further supported by Dr.Shinde in the Governing Body. Dr.Shinde suggested that the College may consider introducing OSM for College Exams.

It was discussed that on a trial basis it can be started on a small level.

4. To report on retirement of Prin.Dr.Sonali Pednekar on attaining the age of 62 on 31/12/2025 and to update on the ongoing process for filling the post of Principal.

Mr.Ganu announced the superannuation of Principal Dr. Sonali Pednekar on 31/12/2025 attaining the age of 62.

Also, Governing Body was updated about the ongoing process for appointment of Principal. After receiving the NOC from the Govt., advertisement was published on 29/10/2025 in two nationalized newspaper i.e. Times of India and Maharashtra Times. University Nominees for Scrutiny Committee have been invited for scrutiny of applications on 01/12/2025 at PTVA.

5. To report on submission of Degree College workload (NEP) to Joint Director's Office as per their circular received.

As per the Circular dated 09/10/2025 received from Joint Director regarding submission of workload as per NEP and information of teaching and non- teaching posts on the basis of student's strength as of 01/10/2025 in their prescribed formats.

Accordingly the information was submitted to the Joint Director and the current staff on role have their full workload and no one is rendered surplus.

6. To report on promotion of Teachers under CAS.

Principal reported CAS of maximum teachers due have been processed at the College/University/Joint Director 's level and their salary implementation is also complied with, expect the case of Dr.Pramila pending at Joint Director level, due to her LL.M. increment.

Mrs.Riya Dhamapurkar from Stage 2 to Stage 3 and Dr.Arjun Lakhe from stage 3 to stage 4 proposals have been forwarded to University for University Nominees.

Governing Body noted the same.
